2022 WASTE CONTRACT:

Waste Connections:

-Option 1 without recycling \$281.88 - \$70.47/quarter. Aggregate price \$308.38

-Option 2 with recycling \$293.88 - \$73.47/quarter. Aggregate price \$320.38

Bag price \$20 for a minimum of 12 tags and \$6.50/tag

Will still continue large item pickup each week. Must call for pickup

Electronics recycling 2 times/year.

Waste Management:

-Option 1 without recycling \$243/year - \$60.75/quarter. Aggregate price \$304.75

-Option 2 with recycling \$302.40/year - \$75.60/quarter. Aggregate price \$364.15

Bag price \$57 for minimum of 12 tags and \$4.75/tag

A Motion to accept Option 2 for Waste Connections was made by Martha Schriver and 2nd by Dan Kuhn. Motion carried.
